We found at least 5 jobs related to the Pharmacy Technician job category that pay more per year than a typical Pharmacy Technician salary in Fresno, CA. Top examples of these roles include: Hospital Pharmacy Manager Assistant Director Of Pharmacy, and Clinical Pharmacy Technician.

Importantly, all of these jobs are paid between \$5,100 (12.8%) and \$99,777 (250.8%) more than the average Pharmacy Technician salary of \$39,790. If you're qualified, getting hired for one of these related Pharmacy Technician jobs may help you make more money than that of the average Nurse position.

The IET Quality Indicators constitute a tool for supporting program development and continuous improvement in IET programs.

- They are organized into five categories:
 - 1. IET Program Design
 - 2. Collaboration and Industry Engagement
 - 3. Curriculum and Instruction
 - 4. Student Experience and Progress
 - 5. Program Management/Staffing/Organization Support



IET Program Design refers to the intentional design and development of a program that meets the needs of local labor markets; provides a pathway to quality jobs; and aligns with federal and state policies.

 Meets local labor market needs, as evidenced by labor market information (LMI), research, and employer validation; and creates a pathway to quality jobs.

WIOA: IET

Integrated Education And Training

IET is a service approach that provides adult education and literacy activities concurrently and contextually with workforce preparation activities and workforce training for a specific occupation or occupational cluster for the purpose of educational and career advancement (§463.35).

An IET program must include the following three components:

- 1. adult education and literacy activities
- 2. workforce preparation activities
- 3. and workforce training (§463.36)

In addition, as part of a career pathway (§463.37), the design of an IET program should **support the local and state workforce development board plans** as required under WIOA.

WIOA: IET Workforce Preparation Activities

Workforce Preparation Activities as cited in §463.34 are a required component of an IET program and may include the following:

- 1. Activities, programs, or services that are designed to help an individual acquire a combination of basic academic skills, critical thinking, digital literacy, and self-management skills
- 2. Employability skills that address competencies in <u>using resources and information</u>, <u>working with others, understanding systems, and obtaining skills necessary to successfully transition to and complete postsecondary education, training, and <u>employment</u></u>
- 3. Other employability skills that increase an individual's preparation for the workforce

WIOA: IET Workforce Training

Workforce Training must include at least one of the following as described in WIOA law section 134 (c) (3) (D):

- 1. Occupational skills training, including training for nontraditional employment
- 2. On-the-job training
- 3. Incumbent worker training
- 4. Programs that combine workplace training with related instruction, which may include cooperative education programs
- 5. Training programs operated by the private sector
- 6. Skill upgrading and retraining
- 7. Entrepreneurial training
- 8. Transitional jobs
- 9. Job readiness training
